### ALL DEPOSIT CHECKS ARE DUE UPON INITIAL BOOKING

A deposit check of 25% of the hunt cost is required to book a hunt, a second deposit check of 25% post dated for January 15 (fall hunt) or Dec. 01 (spring hunt) of the hunt year and then the final 50%, GST tax and licence fees postdated for July 01 (fall hunt) or Mar. 1 (spring hunt). Deposits are non-refundable and may be transferred to a friend but not a future year. If Willow Creek Outfitters (WCO) cancels the hunt then WCO will return your deposit in full.
